



## Instructions to Authors of Articles in Podjetje in delo/Company and Labour

1. Authors are obliged to adhere to the provisions of the Podjetje in delo/Company and Labour Publication [Ethics and Publication Malpractice Statement](#), which are based on the publication ethics of the Committee on Publication Ethics (COPE Best Practice Guidelines for Journal Editors).
2. The journal publishes articles in Slovenian and English and, occasionally, in German and Croatian. Articles sent to the editorial board for publication must be suitable from a linguistic point of view. An article that has not been compiled in accordance with the instructions shall be returned by the editorial board to the author for amendment, or rejected for publication. Articles shall be corrected for language and returned to the author for review and authorisation.
3. Articles should be compiled in digital form using Microsoft Word. Pages should be one-sided with margins of 2.5 cm (A4 size). The text should be presented in Times New Roman 10, font size 10 and 1.5 line spacing. Academic and specialist articles should, as a rule, be no shorter than 8 pages and should not exceed 32 typewritten double-spaced pages (60,000 characters with spaces or approx. 30 pages with 1.5 line spacing), including running footnotes, a list of references, and any tables and figures. Figures, drawings, diagrams and tables, which must be numbered, should only appear in the article if the author refers to them in the text. The source of an illustration or table taken from another work must be indicated as a component part of its explanatory description (alongside the illustration or table).
4. The elements of an article should be arranged into the following order:
  - a. **Author.** The author's full name (first name and surname) should be stated above the title of the article. The following details should be provided in the first (unnumbered) footnote below the line, after the author's full name: professional title, employment/name of institution in which the author is employed, email address. If there is more than one author, the authors shall decide themselves on the order in which they are to be stated. The precise address (with email address) of the author with whom the editorial board will be in contact during preparation of the article for publication must be stated (see the [article submission form](#)).
  - b. **Acknowledgements.** Any assistance in the preparation of the article should be mentioned in the first (unnumbered) footnote that follows the author's details. The full name of the person(s) being acknowledged should be given, along with the type of assistance rendered to the author.
  - c. **Title.** The title should be short and clear, and should make a precise reference to the content of the article. The title should contain words suitable for indexing and search purposes. The title must also be given in English.
  - d. **Table of contents.** The table of contents must contain the section titles as they appear in the article. Example:
    1. *Introduction*
    2. *Basic concepts*
      - 2.1. *Financial instrument*

- e. **Abstract and key words.** The table of contents should be followed by an abstract of not more than 250 words and a list of up to 10 key words. Both should also be in English.
- f. **Sections and subsections.** Articles should have clearly separated sections (chapters). The titles of the sections should be in bold. Chapters and sub-chapters should be numbered decimally (1., 1.1., 1.1.1., etc.).
- g. **Text of the article and citations in the footnotes.**

- i. References are to be given in the form of footnotes using the abbreviated form, e.g.

See S. Cigoj (1981), p. 200.

Where two or more consecutive footnotes refer to the same work, the information should be given only in the first of the footnotes. In every further consecutive reference, the word *ibidem* should be used, followed by the number(s) of the page(s) cited.

*Ibidem*, p. 202.

- ii. Where reference is made to several works or sources by the same author published in the same year, they should be distinguished by placing a letter after the year.

M. Kocbek (2016a), p. 115; M. Kocbek (2016b), p. 394.

- iii. Where a source has more than three authors (or there is a contribution by a single author in such a source), only the lead author should be mentioned, followed by *et al.* All authors should be mentioned in the list of references.

M. Juhart, in M. Juhart *et al.* (2011), p. 99.

- iv. Where reference is made to a secondary source that refers to a primary source, both sources should be mentioned in the footnote. The primary source should be mentioned first, followed by the words *taken from* and a reference to the secondary source. Only the latter should be mentioned in the list of references. This form of citation is only to be used for older sources and sources that are more difficult to access.

B. Vizner (1978), taken from N. Plavšak (2009), p. 198, argues ...

- v. Upon its first mention in the text, a law or regulation should be given its full title, followed by its abbreviation in brackets,

e.g. Employment Relationships Act (ZDR-1).

The reference number of the official journal in which the regulation was published, or in which the most recent official consolidated version was published, should be mentioned in the footnote below the line. Depending on the version of the regulation to which the author is referring, suitable reference should be made to the reference numbers of the official journal in which the amendments were published.

References to specific articles should be made in the main text rather than using footnotes, e.g.

As defined by article 38 of ZDR-1, ...

- vi. Judicial decisions of Slovenian and foreign courts. A judicial decision should be referred to as designated by the court that issued it. Reference should be made to the court, or the abbreviation for the court given, with a reference number and the date of issue of the ruling. The abbreviation 'ECLI' may also be added.

Judgment of the Supreme Court of the Republic of Slovenia Ruling I Up 150/2008 of 17 April 2008.

- vii. European Court of Justice case-law. The reference number of the case, the names of the parties (in full or abbreviated) and the abbreviation 'ECLI' should be given

Complete information for references to European Court of Justice case-law (as well as to EU legislation and other legal acts) can be found on the eur-lex.europa.eu website.

- viii. European Court of Human Rights case-law. The names of the parties and the case reference number should be given. The abbreviation 'ECLI' should also be attached to more recent cases.

- h.** List of references. The sources cited should be collected at the end of the text in the 'List of references' section. Only sources to which the author refers in the text and that have been published or are publicly available should be placed in the list of references. The references should be listed in alphabetical order. If a source has a digital object identifier (DOI), this must be included in the reference to the source (for more information, see Crossref, [www.crossref.org](http://www.crossref.org); [www.crossref.org/guestquery](http://www.crossref.org/guestquery); <http://dx.doi.org/>).

- i. For books, the first name and surname of the author or authors, the title of the work, the place of publication, the publisher and the year of publication should be given. For online e-books, the name of the website should be added after the publisher's details, followed by the URL and the date of access.

- ii. For a paper or chapter in a book or a commentary on an article of a law, the first name and surname or the author of the paper or chapter with the year of publication in brackets, and the title of the paper or chapter should be given, followed by information on the book itself: the author's, editor's or publisher's surname and first initial, the title of the book or commentary, the place of publication, the publisher, and the pages on which the cited paper is published (first and last page) or the chapter number.

- iii. For articles in journals and other periodical publications, the author's surname and first name should be given, along with the year of publication in brackets, the title of the article and the journal, the issue number or volume, and the pages on which the article is published. For articles in online e-journals, the name of the website, the URL and the date of access should also be added.

- iv. For a paper in a collection (journal, proceedings), the first name and surname of the author of the paper should be given, along with the year of issue or publication in brackets and the title of the paper, followed by information on the collection: the editor's surname and first initial (if the collection has no editor, only the title of the collection is given), the title of the collection, the place of issue or publication, the publisher, and the pages on which the paper is published. For a paper in an online e-collection, the name of the website, the URL and the date of access should also be added.

- v. For an undergraduate, Master's or doctoral dissertation, the author's first name and surname should be given, along with the year in brackets, the title (and sub-title) and type of text, the place, the university and the faculty.

- vi. The work of a known author taken from the worldwide web that has not been published in printed or e-journal form should be included in the list of references. The author's first name and surname, the year of publication, the title of the work, the URL and the date of access should be given.

- vii. If reference is made to more than one work by the same author, those works should be listed by year of publication from the oldest to the newest. If the same author is also the author of a work with more than one other co-author, his/her work or work of sole authorship should be given first, followed by his/her work or works with other co-authors. In each reference, reference must be made to all authors regardless of their number.
- viii. If the source does not have an author, or if the author is unknown, the title should be the first item mentioned in the reference.

- ix. Where reference is made to unpublished work that is still being printed, all the prescribed information should be given, with *in preparation* replacing the year of publication or issue in brackets.
- x. All information should be in the original language. With foreign-language sources, the Slovenian translation may be placed after the original title in brackets. Sources that are not publicly available, e.g. unpublished lectures or reports, personal interviews, emails, etc. should not be cited.

**i.** Legislation and other domestic and foreign legal sources. All legislation and other legal sources should be given only in running footnotes, with the full title of the source and all pertinent information.

**5.** Articles must be submitted to the journal's editorial board via the online article submission form or directly to the [editor-in-chief's email address](#). By submitting the article, the author signals that he/she accepts the editorial policy and the provisions of the Podjetje in delo/Company and Labour Publication Ethics Statement. The editorial board is entitled to accept or reject the submission in its own discretion. It is not obliged to return the submission, or provide further explanation regarding the review decision. The journal does not disclose who reviewed the article. Corrections made to the articles will only be published if approved by the author.
